If you are invited by the Chinese side, "Invitation Letter of Duly Authorized Unit" or "Confirmation Letter of Invitation" is also required.6. Citizens of Singapore, Brunei and Japan holding ordinary passports may enter China without a visa through the ports of entry open to foreigners provided that they come to China for tourism, family visit, business or transit, and intend to stay in China for no more than 15 days. However, the following personnel of these three countries must apply for a visa in advance if:a) They are holders of ordinary passports, and come to China for tourism, family visit or business, and intend to stay in China for more than 15 days;b) They are holders of ordinary passports, and come to China for study, employment, permanent residence or on a news reporting mission;c) They are holders of diplomatic and service(official) passports;2. Foreigners holding ordinary passports of the countries having diplomatic relations with China and on a tour to Hong Kong or Macao, and participating in group tours to the Zhu Jiang River (Pearl River) Delta Area for a stay of less than six days organized by the travel services legally registered in Hong Kong or Macao shall not need to apply for a visa. The Zhu Jiang River (Pearl River) Delta Area refers to the administrative area of the 10 cities below: Guangzhou, Shenzhen, Zhongshan, Jiangmen, Zhaoqing, Huizhou and Shantou. 3. Foreigners who have confirmed onward tickets and seats on international flights and directly transit through China and stay for no more than 24 hours within the airport boundaries shall not need to apply for a transit visa.4. No visa is required for citizens of the following 20 countries, who transit through China via Shanghai within 48 hours, no matter what types of passport they may hold: Republic of Korea, the United States of America, Canada, Australia, New Zealand, and the Schengen states -- Germany, France, Austria, Sweden, Denmark, Norway, Finland, Iceland, the Netherlands, Belgium, Luxemburg, Spain, Portugal, Greece and Italy.5. Citizens holding ordinary passports of the following 21 countries and in group tours to Hainan Province for a stay of no more than 15 days organized by the international travel services approved by the National Tourism Administration of China and registered in Hainan Province shall not need to apply for a visa:Malaysia, Thailand, the Philippines, Indonesia, the UK, France, Austria, Italy, Switzerland, Sweden, Spain, the United States of America, Canada, Australia, New Zealand, Finland, Denmark, Norway, Ukraine and Kazakstan. Citizens holding ordinary passports of the following 3 countries and in group tours to Hainan Province for a stay of no more than 21 days organized by the international travel services approved by the National Tourism Administration of China and registered in Hainan Province shall not need to apply for a visa: Republic of Korea, Germany and Russia.Documents Required1. Original passport with at least two blank visa pages. For single entry visa, your passport should be valid at least 6 months; For double-entry or multiple-entry(six-month) visas, your passport should be valid at least 9 months; For one year multiple-entry visa, your passport should be valid at least 15 months; 2. One completed Visa Application form should be completed neatly with genuine information; 3. Non-Singapore citizens shall provide documents that entitle them to reside for an extended period of time in the SPR, WP, EP, STP, DP. Temporary visitors to Singapore should apply for a Chinese visa in their own country. For the special cases, consular officer has the rights to make the final decision on whether issuing a visa or notAdditional documents: Tourist and Family Visit (L) Visa: - Round-trip airline tickets and hotel reservation, for family visit should provide certificate of relationship and round-trip airline tickets and hotel reservation; - Applicants planning to tour Tibet may join a tourist group organized by an authorized local travel agency. Work Visa (Z-visa)- Employment Approval Documents required:1) Foreigners who come to China to take up employment as experts, scholars, teachers, managerial personnel and as personnel working in related state or local organizations should provide: Permit for Foreign Experts Working in China issued by the State Bureau of Foreign Experts (original copy); An "Invitation Letter of Duly Authorized Unit" or "Confirmation Letter of Invitation" issued by an authorized unit in China (original copy).2) Foreign technical personnel who come to China for Offshore petroleum operations should provide Letter of Invitation to Foreigners for Offshore Petroleum Operations in China issued by China National Offshore Oil Corporation (original copy);3) Chief representative or representative of foreign offices resident in China should provide: The registration certificate of resident representative office of foreign (regional) enterprise issued by related administrative department of industry and commerce; or the approval document for the resident representative office of foreign enterprise issued by related commercial departments; and an "Invitation Letter of Duly Authorized Unit" or "Confirmation" issued by an authorized unit in China (original copy).4) Personnel who come to China to implement aid or cooperative projects should provide: Bilateral or multilateral agreement between the Chinese government and foreign government or international organization, for cooperation and exchange; An "Invitation Letter of Duly Authorized Unit" or "Confirmation Letter of Invitation" issued by an authorized unit in China (original copy).5) Personnel who come to China for commercial performance should provide: Approval document (also copy) issued by the Ministry of Culture or the Cultural Department of related province, autonomous region or municipality directly under the Central Government; An original copy of "Invitation Letter of Duly Authorized Unit" or "Confirmation Letter of Invitation" issued by the Ministry of Culture or the foreign affairs office of related province, autonomous region and municipality directly under the Central Government.6) Personnel other than those mentioned above should provide: The Employment Permit for Foreigners issued by the Ministry of Human Resources and Social Security; An "Invitation Letter of Duly Authorized Unit" or "Confirmation Letter of Invitation" issued by an authorized unit in China (original copy).7) Accompanying family dependents of personnel working in China should provide an original copy of "Invitation Letter of Duly Authorized Unit" or "Confirmation" issued by the authorized Chinese unit or proof of kinship, e.g. marriage certificate, birth certificate, etc., and a copy of the Z-visa as well as Residence Permit of the person working in China.- A Physical Examination Record for Foreigner filled out and signed by a doctor (together with their copies). Method for application Chinese embassy does not directly accept visa application for ordinary passport holders. Applicants who hold ordinary passports please proceed to China Visa Application Service Centre. An application to the Centre in person or entrust someone or a travel agency to submit on his or her behalf. You may book in advance via the Centre's website for submission. You may be required to go to the Chinese Embassy for an interview if the Chinese Embassy deems it necessary.period of validityUnless specifically requested by the applicant in his or her completed application form and approved by Consular Officers, a single-entry visa is valid for three months, and a double-entry visa valid for six months, both with a 30-day duration of stay. Please apply for a visa about one month in advance of your intended date of entry into China, and do not apply three months earlier than your intended date of entry into China. You should take upon yourself any consequences resulting from your failure to submit visa application at an appropriate time, which may lead to either your already-issued visa becoming expired or it would be too late to get a visa before your planned departure date. Notice June 25, 2012Based on the principle of reciprocity, from July 5, 2012, the Chinese Embassy in Singapore will suspend the express and rush visa service to the passport holders (including the diplomatic & official passport holders) of the following countries: Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Iceland, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland. The granted China Visa Singapore will be stamped on the passport of the applicant. Hence physical passport of the applicant will be held by the China Embassy Singapore during the processing of China Visa Singapore. Withdrawal of passport during the China Visa Application processing in Singapore will be subject to approval of Chinese Embassy from case to case. China Visa Singapore does not allow applicant to enter Macau and Hong Kong. Separate Visas have to be applied for Macau and Hong Kong. The validity period given for using China Visa in Singapore will be three months. Multiple Entries for China Visa Application for business will be subject to approval of China Embassy Singapore. However in few cases granting of Visa Validity might change as per discretion of China Embassy Singapore Detailed Requirements for China Visa. Application in Singapore as Visa will be stamped on the passport. Passport should have at least three blank pages one for visa stamping of entry/exit stamps in passport at the immigration in China. Passport should be valid for at least 9 months to apply for China Visa Singapore. If passport validity is less than 9 months it is better to renew the passport before applying for China Visa. IC Copy Singaporean PR should enclose the copy of the NRIC and re-entry permit copy along with the China Visa Application as this is requirement by China Embassy. Singapore Long Term Pass Holders, Employment Pass Holders, Dependent Pass Holders, S Pass Holders, Student Pass Holders, Personalised Employment Pass Holders, Entre Pass, Training Employment Pass applying for China Visa should attach a copy of the pass along with your China Visa Application. It is to be noted that the pass validity should be at least three months valid at the time of submission of China Visa. Photograph for China Visa Singapore To apply for China Visa Singapore, you would require one photograph. The photograph should be of white background. The photograph size required for the China Visa Application is 35 mm X 45 mm, as mentioned by China Embassy Singapore. The photograph should be latest, front facing with most exposure is on the face. Long distanced photographs, photographs of dull and blurred visibility are not accepted. Hotel Booking /Flight Booking Hotel and Flight booking are mandatorily required for China Tourist Visa Applications. It is not mandatory to provide confirmed tickets to China. The flight and hotel can be itineraries or bookings for China. Again this is as per the guidelines mentioned by CHINA EMBASSY SINGAPORE If applicant is staying with friends or relatives in China, applicant should provide the Inviter passport copy, PRC ID copy and invitation letter in English from the inviter instead of hotel booking. Official Invitation Letter from China should be as per China Embassy Singapore Applicant should provide invitation letter from China. Letter should be colour print out. Company letter head with signature and seal of the China Company. Letter should be in English only. Letter should brief the position of the applicant, designation, purpose of travel and intended days of stay in China. Official Undertaking Letter from Singapore Applicant should provide undertaking letter from Singapore. Original Letter should be submitted. Company letter should be on company letter head with signature and seal of the Singapore Company. Letter should be in English only. Letter should brief the position of the applicant, designation, purpose of travel and intended days of stay in China.
